

Terms and conditions of British Council special offers

Special offers for adult learners

1. British Council English course limited-time offer

Adult English courses

- The referral programme is applicable to existing British Council students who refer one or more new students to register for British Council English course; MyFoundation; IELTS Preparation (Foundation) or Professional Business Skills. Students who have completed their courses or whose packages have expired are not eligible.

- 'New students' are defined as those who have never been a student on any British Council English course before.
- There is no limit to the number of referrals during the programme period, but each new student can only be referred once.
- The referral programme is not applicable to IELTS Preparation (CEF) and IELTS Mock 1-to-1.
- Where an existing student refers a new student to register for a British Council English course or MyFoundation course, the new student must register for the 60-lesson British Council English course package or three modules or above of a MyFoundation course in one transaction for the referral programme to be applicable. Where an existing student refers a new student to register for a Professional Business Skills course, the new student must register for four modules or above of the course in one transaction for the referral programme to be applicable.
